

RESOLUTION 24-018

WHEREAS, in compliance with Florida Statutes, at the meeting of the SANIBEL FIRE AND RESCUE DISTRICT, BOARD OF COMMISSIONERS held on JULY 10<sup>TH</sup>, 2024, the following resolution is hereby adopted:

NOW, THEREFORE, BE IT RESOLVED, by the COMMISSIONERS OF THE SANIBEL FIRE AND RESCUE DISTRICT BOARD that the documents attached hereto, will be made part of this resolution, and indicates the following:

A RESOLUTION THUS, PROVIDING FOR THE DISTRICT'S BOARD TO ADOPT THE TENTATIVE MILLAGE FOR THE FISCAL YEAR 2024-2025, BY USING THE MILLAGE OF 1.700 WHICH WOULD EXCEED THE ROLLED BACK RATE OF 1.3915 MILLS RESULTING IN A TAX PERCENTAGE INCREASE TO RESIDENTS OF THE DISTRICT OF 22.17%.

ALSO INSTRUCTING THE DISTRICT'S ADMINISTRATION TO COMPLETE THE DR420 AND THE DR420-MMP AND SUBMIT THEM TO THE COUNTY WITH THE ESTABLISHED MILLAGE RATE OF 1.700 AND SETTING THE FIRST PUBLIC BUDGET HEARING DATE FOR 9/5/2024, AT 5:01 PM AND THE FINAL PUBLIC BUDGET HEARING DATE FOR 9/18/2024 AT 5:01 PM.

WHEREAS, THE BOARD OF COMMISSIONERS OF THE SANIBEL FIRE AND RESCUE DISTRICT desire to adopt said policy in accordance with the current laws of the State of Florida.

A COPY OF ALL LEGAL FORMS AND LETTERS FOR THE SAID ITEMS IS ATTACHED HERETO AND A COPY WHICH IS ON FILE WITH THE FIRE CHIEF IS HEREBY APPROVED AND ADPOTED.

This procedure will commence JULY 10<sup>th</sup>, 2024.
