A resolution of the Sanibel Fire and Rescue District of Lee County, Florida, adopting the tentative levy of Ad Valorem Taxes for Fiscal Year 2022-2023; providing an effective date.

WHEREAS, in compliance with Florida Statutes 200.065, at the tentative budget hearing and adopting the tentative FY 2022-2023 Final Millage Rate of the SANIBEL FIRE AND RESCUE DISTRICT, BOARD OF COMMISSIONERS held on SEPTEMBER 14TH, 2022; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Lee County has been certified by the County Property Appraiser to the Sanibel Fire and Rescue District as \$6,478,907,395.00, the following resolution is hereby adopted:

NOW, THEREFORE, BE IT RESOLVED, by the COMMISSIONERS OF THE SANIBEL FIRE AND RESCUE DISTRICT BOARD that the documents attached hereto, will be made part of this resolution, and indicates the following:

THE FISCAL YEAR 2022-2023 OPERATING MILLAGE RATE FOR SANIBEL FIRE AND RESCUE DISTRICT IS TENTATIVELY SET AT 1.2365 MILLS, WHICH EXCEEDS THE ROLL-BACK RATE OF 1.1642 MILLS RESULTING IN A TAX PERCENTAGE INCREASE TO RESIDENTS OF THE DISTRICT OF 6.21%, PROVIDING FOR PROCEEDS OF \$8,011,169.00. THIS RESOLUTION SHALL TAKE EFFECT IMMEDIATELY UPON ITS ADOPTION.
