

RESOLUTION 20230907

A resolution of the Sanibel Fire and Rescue District of Lee County, Florida, adopting the tentative levy of Ad Valorem Taxes for Fiscal Year 2023-2024; providing an effective date.

WHEREAS, in compliance with Florida Statutes 200.065, at the tentative budget hearing and adopting the tentative FY 2023-2024 Final Millage Rate of the SANIBEL FIRE AND RESCUE DISTRICT, BOARD OF COMMISSIONERS held on SEPTEMBER 7TH, 2023; and

WHEREAS, the gross taxable value for operating purposes not exempt from taxation within Lee County has been certified by the County Property Appraiser to the Sanibel Fire and Rescue District as \$4,217,789,351, the following resolution is hereby adopted:

NOW, THEREFORE, BE IT RESOLVED, by the COMMISSIONERS OF THE SANIBEL FIRE AND RESCUE DISTRICT BOARD that the documents attached hereto, will be made part of this resolution, and indicates the following:

THE FISCAL YEAR 2023-2024 OPERATING MILLAGE RATE FOR SANIBEL FIRE AND RESCUE DISTRICT IS TENTATIVELY SET AT 1.400 MILLS, WHICH EXCEEDS THE ROLL-BACK RATE OF 1.1061 MILLS RESULTING IN A TAX PERCENTAGE INCREASE TO RESIDENTS OF THE DISTRICT OF 26.57%, PROVIDING FOR PROCEEDS OF \$5,904,905. THIS RESOLUTION SHALL TAKE EFFECT IMMEDIATELY UPON ITS ADOPTION.

SANIBEL FIRE AND RESCUE DISTRICT ESTABLISHES THAT ON SEPTEMBER 20, 2023, AT 5:01 PM AT THE SANIBEL FIRE AND RESCUE DISTRICT, STATION 171, 2351 PALM RIDGE ROAD, SANIBEL, FLORIDA 33957, THE FINAL ADOPTION OF THE DISTRICT'S MILLAGE RATE AND BUDGET WILL TAKE PLACE.

WHEREAS, The Board of Commissioners of the Sanibel Fire and Rescue District duly adopted at a public hearing this, the 7th Day of September 2023.
